- Fill out and send or <u>email</u> this application to the email/mail address above by <u>November 15, 2010</u>. No late applications will be accepted due to the printing deadlines for our farm list.

- 2) The MACSAC New Grower Committee will review your application and set up a 1 hour meeting with you to explain how the coalition works, answer any of your questions, and judge your ability to manage a successful CSA farm.

- 3) The New Grower Committee will make a recommendation to the MACSAC board about whether to formally represent applicant farm for the coming season.
- 4) Farm is notified of decision by December 31st. Possible decisions are
  - Acceptance Your farm will be formally endorsed by MACSAC beginning on January 1, 2010
  - **Deferral** MACSAC believes your farm is compatible with our goals and mission, but we would like you to gain additional experience and address areas of concern before we formally endorse you. MACSAC will work with you to address the areas of concern and we encourage you to reapply for endorsement next year. MACSAC will communicate with you about mentorship opportunities and encourages you to take advantages of resource sharing opportunities of the coalition.
  - *Rejection* Your farm is not compatible with MACSAC's goals and we cannot endorse you unless you make major changes on your farm. If you make these major changes to your farm you are encouraged to begin the application process again next year.
- 5) Farm is welcome and encouraged to attend the MACSAC annual meeting on <u>December 11</u>.

- Communicate information about MACSAC programs to my members including the Partner Shares fund for low-income households, Insurance Provider Rebate Program, A-Z Foodbook, and MACSAC events
- **D** Provide MACSAC with annual information regarding acreage and number of members
- Provide members with the opportunity to make donations to the Partner Shares Fund or farm specific assistance fund for low-income members

# NON-VEGETABLE APPENDIX

### Pasture and Feed

## **Dairy**

Is your milkhouse licensed with the Wisconsin Department of Agriculture and has it passed the Dairy Producer License inspection?

Do you have a good relationship with your inspector?

Do you have a valid method to test each batch of milk for your cheesemaking, butter or milk processing for the presence of antibiotics? (Even though antibiotics are not allowed for organic production, the state of Wisconsin still needs an antibiotic test result for each batch).
